From the Desk of the Chief



Inspired Living, Cypress Creek Villages, Cypress Creek Assisted Living, Home Depot, Denny's, Wendy's, Popeye's, Bob Evans, Bealls, Walmart, and the new Wa Wa gas station are not within our service area and we have to be requested by HCFR to go to these places. Crew Meeting Summary by Shirley Bardell

For new volunteers and all of our returning snowbirds, there have been policy and protocol changes in our patient care. Please know that we now have a Medical Policy/Procedure Notebook for our protocols that will be located behind the captain's desk. Only patient care procedures will be in the book, versus all of our Squad policies that are located in the Policy/ Protocol Manual.



Below are a few of the changes we are/have been implementing:

Spinal Immobilization – we will follow Hillsborough County practices. This comes from the Hillsborough County Trauma Audit Committee. Please check the new manual for specific procedures.

Stroke Patients – the Stroke alert form has been reactivated by the State. Please complete all sections on suspected Stroke patients and give to either ALS or the hospital. The form can now be found on the back of the Medication sheet

Fall patients – all fall patients must have a blood sugar done. If the patient is complaining of an injury that from a fall that occurred several days before, a blood sugar is at the discretion of the EMT.

Stable vs Unstable patients – vitals every 5 minutes if the patient is unstable; every 15 minutes if the patient is stable. All transports out of Sun City will have a second set of vitals.

Please note the onset time – in your narrative. It does NOT print out, even though it's listed under the incident tab.

Team Training – CPR training will occur every six weeks and will be split over two consecutive weeks.

New Ambulance Checklists – please note that beginning in November, there will be new checklists and some items in the ambulance will have moved; some will be taken off the EMT checklist and be only on the driver checklist. Items involved are: old lift belts removed; hand and foot restraints moved; normal saline added; kneeling pads moved; air splints moved; padded splints moved; emesis bags moved; Sampson belt on gurney; on-board oxygen – only on driver's checklist; red slider under the head of stretcher.



Van CPR – a new procedure is being developed and training will be done in November. Barry Bogart and Barry McKee will head up this training.

Patient Care Reports by Linda Blume

We are now back home. It looks so nice and new. Welcome friends from the North just some friendly reminders for all. Blood sugars on ALL falls per Dr. K. I am noticing a lack of charting in some of the narratives. I am not asking for a book of information but sure need more than 'threw window',' Code Brown', 'threw up lots', 'don't feel so good.' We are responsible for our charting and if you think people don't read your narrative you are very wrong. I receive requests from Attorneys, Patients, Families, Insurance Companies to name a few. Patients and Families can sue up to 7 years. Do you think you will remember an incident with some of the charting that you have done or will be able to defend it?

Vitals are to be taken every 15 minutes. Head to Toe exams on all FALLS. HIPPA signatures can be signed by friend, spouse, neighbor, Health care Facility staff-it just states the HIPPA form was left.

Tis the season for Colds, Flu, and other illnesses. Protect yourself and your families. Someone is coughing have them wear a mask. A mask can be worn even if they are on Oxygen. Wear gowns and gloves you don't want to take anything home on your clothes.

All RESPONDING ambulance calls (911) are to be running with Lights and Sirens .Leaving the Scene is usually No light or Sirens but is left up to the discretion of the EMT on board.

The only exception is Medical Transports. Medical Traports are from South Bay Hospital to Health Care Facilities. No lights or sirens are used in that case.



Crew Safety - by Mike Albanese

There are many times that backing up the ambulance requires having one of the crew members assist. Please remember if you are assisting the driver in backing up the ambulance:

- Put on your green safety vest first, before you step into the street.
- Assess traffic, be sure they see you before you step into the road to back up the vehicle. Make eye contact if possible, with the drivers closest to you.
- Make sure <u>all traffic stops before you signal the driver that it's clear to</u> back up.
- Make sure the ambulance driver can see you in his mirrors so you don't become a patient!
- Keep an eye on traffic to make sure they don't try to sneak around you and the ambulance.
- Study and review our training on hand signals for spotters.
 Most of all – be sure YOU are safe

<u>Emergency Squad's Featured Volunteer –</u> Beverly Shackleford
