Both red bags and plastic trash bags are on the ambulance. Place soiled linen in one of these containers and make sure it gets to the hospital. Aston Gardens has made a request to remind our ambulance crews that the staff at Aston Gardens sends their security staff to residents rooms when someone needs help (either medical or some other emergency) to be an advocate for the resident and ensure the apartment is secured and contacts are informed for the resident. Please do not bar them from the apartment. Allow them to do their job, they should not be in the way and they may be a good source of information.

Their is another request I must bring up. Again, it is a reminder about private information at the Squad. Anything with a full name, address, ssn, or any combination of these needs to be disposed of properly. None of these documents can be thrown in the trash, they must be put in the shred box. This request came about because members of the Squad have been finding our old rosters in the trash cans. Please dispose of the old rosters in the shred box in the copier room. If any of you see any information from above, please remove it and alert the Captain or dispose of it in the shred box. Thank you.

ISOLATION ISSUES

Ensuring that our isolation procedures are used routinely, is very important to all of us. At this time of year with so many visitors, it is especially important because we are exposed to many more "bugs." Hand washing is your number one defense tool. Anti-bacterial hand gel is handy but does not fight C-diff. Hand



gels are great for a quick clean up, but your hands need to be washed with soap after 7 uses of gel. In fact, it's the friction that cleans the hands, so if you are stuck without soap just use water and rub the hands back and forth.

Please remember to wipe down the equipment after each patient to help prevent cross-contamination.

When dealing with C-Diff (once you deal with it you will never forget it) All equipment must to cleaned with 1/2 cup of Bleach in 1 gallon of water. AIR DRY FOR 5 MINUTES. Clean the stretcher before leaving the hospital or facility and make up the stretcher when you return to base.

Chart regarding Infection Control and Epidemiology is at the Captains Desk for any questions or drop me an e-mail.

If you encounter bloody towels, wraps, bandages place in a red bag and leave at the hospital. Please make sure you are wearing gloves.

Going on a Cruise? Make sure you are covered!

Did you know that when you go outside the United States that Medicare does not provide emergency medical care (in most cases)? This is primarily because Medicare is not accepted anywhere, but in the U. S.

In most situations, Medicare will NOT pay for health care services or supplies that you receive when you are travelling outside the United States or its territories. However, Medicare allows a cruise ship's doctor, under certain laws, to provide medically necessary health care services if:

- The vessel is of American registry
- The physician is duly registered with the Coast Guard to render the professional services in question, and

The services are rendered while the ship is in a U.S. Port (or within 6 hours of departure or arrival at a U.S. Port) regardless of whether it's an emergency.

If the ship is more than 6 hours away, Medicare will NOT cover health care services.

If you are considering foreign travel, there are several Medicare supplements that offer foreign travel coverage. Or check your Advantage plan to see if you have foreign travel coverage. You might also ask your travel agent what travel insurance covers.

Be a safe and wise traveler this year and make sure you have health care coverage when you go abroad. We want everyone to come back healthy!

Debbie Jasmer, EMT—Off duty Hero

On Wednesday night February 1st, a drunk driver collided with a vehicle carrying seven passengers, five of whom were children. This occurred on College Avenue in Ruskin, right across from Debbie Jasmer's food truck. Debbie was serving a customer when the crash occurred. She immediately jumped into action, triaging the victims to determine their injuries and the care they needed. Other bystanders assisted and took their directions from Debbie, who assigned them their duties and then quickly attended to a 3 year old child, who was most critically injured.

Debbie did CPR on the 3 year old for over 12 minutes until a deputy arrived and took over. Two of the children were seriously injured. Only one

child had been appropriately belted into a child safety seat.

Debbie is quick to acknowledge the Squad's training and her EMT education for providing her the ability to jump into action when she was most needed. We are so glad to have her in our Squad
